The Chairperson read the following opening statement before convening the meeting:

"This Committee meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Automobile Insurance Plan. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion or intimidation."

- 1. Chairperson Lindstedt was advised that a quorum was established and the meeting was declared open for business.
- 2. The reading of the minutes of the last Annual Meeting was waived, and the minutes were approved as published.
- 3. Plan Manager Herrmann summarized the activities of the Plan for the past year. The number of Commercial application submissions has remained constant with a slight increase in the number of trucking risks. There has been no new Private Passenger applications assigned by the Plan in 21 months.

Plan Manager Herrmann also thanked the entire Plan membership for their continued support, and specifically thanks all members of the Governing Committee, the Subcommittees, the Office of the Commissioner of Insurance and AIPSO for their commitment and hard work during 2003.

3. The next order of business was the election of the representatives for the four industry groups.

The National Association of Independent Insurers (NAII) and the Alliance of American Insurers (AAI) recently merged and formed a new trade association known as Property Casualty Insurers Association of America (PCI). As a result of the merger, it is proposed that the WAIP Governing Committee be comprised of two representatives each from the PCI, AIA, and the non-affiliated companies. Once the original six members are selected, the members will select two "at large" carriers to be elected to fill the remaining positions on the Governing Committee.

This amendment will be filed with the OCI for approval.

By unanimous vote, Liberty Mutual Insurance Company was appointed as a servicing carrier for the Plan.

Plan Manager Herrmann then requested nominations for Chairperson. Sentry Insurance A Mutual Company was unanimously re-elected to serve as Chairperson of the Governing Committee for a two-year term

No further business was introduced, and the meeting was adjourned.
