UNFINISHED BUSINESS

ITEM NUMBER 712 SERVICING CARRIER AGREEMENT

ITEM NUMBER 721 AIPSO PROPOSAL - LOSS PAYABLE CLAUSE – MAXIMUM LOSS PAYABLE

The Committee was furnished with a copy of a revised Loss Payable Clause endorsement. The endorsement clarifies the specific the maximum loss payable.

This item was approved for filing with the Office of the Commissioner of Insurance to be effective for private passenger business.

ITEM NUMBER 723 AIPSO PROPOSAL – EXPANSION OF PRIVATE PASSENGER PHYSICAL DAMAGE RATING SYMBOLS

The expanded private passenger physical damage rating symbols have been filed with and approved by the Office of the Commissioner of Insurance effective 1-1-10. This item is removed from the agenda.

ITEM NUMBER 728 COMMERCIAL RATE PROPOSAL

At the July 31, 2009 Governing Committee meeting, an overall commercial rate increase of 20.2% was adopted for filing with the Office of the Commissioner of Insurance. Subsequent to the meeting, the rate proposal was re-evaluated to incorporate the impact of the new mandatory insurance laws. The new indication was an overall commercial rate increase of 19.8% which was filed with and approved by the Office of the Commissioner of Insurance effective 1-1-10 for new business and 3-1-10 for renewal business.

ITEM NUMBER 729 2009 WISCONSIN ACT 28 – MANDATORY AUTOMOBILE INSURANCE

The manual rules and rates affected by the new mandatory automobile insurance law have been approved by the Office of the Commissioner of Insurance effective 11-1-09. The revisions to the applications were filed separately under Item Number 730.

This item is continued on the agenda to monitor future changes or amendments.

ITEM NUMBER 730 COMMERCIAL APPLICATIONS

The revisions to the Truckers and Business Auto applications have been approved by the Office of the Commissioner of Insurance effective 11-1-09.

NEW BUSINESS

ITEM NUMBER 731 WAIP 2010 BUDGET

(This item was assigned number 730 on the agenda. It has been changed to 731 due to the filing of the commercial applications)

The Committee accepted the proposed 2010 budget.

ITEM NUMBER 732 PRIVATE PASSENGER RATE REVIEW

By unanimous consent, this item was added to the agenda.

The current private passenger rates have been in effect since April 1, 1995. While there has been virtually no activity in the assigned risk private passenger area, a review of the current rates was appropriate. Recommended changes of +16.7% for liability, -25.0% for physical damage, and an overall decrease of 1.7% were adopted for filing with the Office of the Commissioner Insurance.

The next WAIP Governing Committee meeting is scheduled for July 30, 2010.
