The Chairperson read the following opening statement before convening the meeting:

"This Committee meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Automobile Insurance Plan. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion or intimidation."

- 1. Chairperson Pousha was advised that a quorum was established and the meeting was declared open for business.
- 2. The reading of the minutes of the last Annual Meeting was waived, and the minutes were approved as published.
- 3. Interim Plan Manager Riegel summarized the activities of the Plan for the past year.

- The WAIP commercial volume continues to decline. 10 applications have been received through July 21, 2010. A total of 69 commercial applications were received in 2009.
- WAIP received no new Private Passenger applications.
- 25 carriers have entered into a LAD agreement.
- Mandatory automobile insurance requirements were signed into law.

Interim Plan Manager Riegel thanked the entire Plan membership for their continued support, and specifically noted all members of the Governing Committee, the Subcommittees, the Office of the Commissioner of Insurance and AIPSO for their commitment and hard work during 2010.

4. The next order of business was the election of the representatives for the four industry groups.
