UNFINISHED BUSINESS

ITEM NUMBER 729 2009 WISCONSIN ACT 28 – MANDATORY AUTOMOBILE INSURANCE

The Committee approved a correction to Rule 104 Nonowned Auto Liability Coverage. The rule inadvertently gave a .50 credit. The Manual amendment will be filed with the Office of the Commissioner of Insurance for approval.

ITEM NUMBER 733 AIPSO PROPOSAL – NAMED NONOWNER RATING ADJUSTMENT

This item was approved by the Office of the Commissioner of Insurance August 23, 2010. With all business complete, this item is removed from the agenda.

ITEM NUMBER 734 AIPSO PROPOSAL – ELIMINATION OF PRIVATE PASSENGER LIABILITY CLASS RATE SCHEDULES

ITEM NUMBER 735 COMMERCIAL AUTOMOBILE RATE REVIEW

ITEM NUMBER 739 AIPSO PROPOSAL AVAILABILITY OF PLAN MANUAL

The Committee adopted an amendment to the Plan Manual regarding the availability of Plan Manuals and forms. The current rule references a \$30 charge for the Manual in hard copy format. Customers interested in receiving hard copy will be referred to AIPSO. The Manual change will be filed with the Office of the Commissioner of Insurance for approval.
