The Chairperson read the following opening statement before convening the meeting:

"This Committee meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Automobile Insurance Plan. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion or intimidation."

- 1. Chairperson Donovan was advised that a quorum was established and the meeting was declared open for business.
- 2. The reading of the minutes of the last Annual Meeting was waived, and the minutes were approved as published.
- 3. Cheryl Korth summarized the activities of the Plan for the past year.
 - The WAIP commercial volume increased slightly. 21 applications were received in 2012.
 - WAIP has not received any new Private Passenger applications since 2007.
 - WAIP filed for a 7.1% decrease in commercial rates to be effective in 2013.

Tad Cleveland thanked the entire Plan membership for their continued support, and specifically noted all members of the Governing Committee, the Office of the Commissioner of Insurance and AIPSO for their commitment and hard work during 2012.

4. The next order of business was the election of the representatives to the Governing Committee. The following carriers were re-elected to serve a one-year term on the Governing Board:

By unanimous vote, National Continental Insurance Company was appointed as an additional member of the Governing Committee in accordance with Rule 1. in Appendix Page C. in the WAIP Manual.

Employers Mutual Casualty Company was unanimously elected to serve as Chairperson of the Governing Committee for a two-year term.

No further business was introduced, and the meeting was adjourned.
