The Committee reaffirmed the December 2013 e-mail vote on changes to the WAIP Servicing Carrier Agreement. The Agreement has been signed by both the WAIP Plan Manager and the Servicing Carrier. National Continental Insurance abstained from voting.

NEW BUSINESS

ITEM NUMBER 773 AIPSO PROPOSAL- PERSONAL VEHICLE SHARING PROGRAM

The Committee voted to adopt endorsement PP 23 16 10 13 Personal Vehicle Sharing Program Exclusion Endorsement proposed by AIPSO. This endorsement and appropriate rule changes will be filed with the OCI to be effective upon approval.

ITEM NUMBER 774 DRIVER LICENSING ABBREVIATION CODES WITH CHARGE POINTS

The Committee was furnished with a copy of the updated WI DOT chart and the current WAIP Rule 24.-Additional Charges which assign penalty points to a limited number of the DOT codes. WAIP staff will research how these conviction codes are used in determining private passenger premium rates in the voluntary market.

ITEM NUMBER 775 AIPSO PROPOSAL 2010 COMMERCIAL AUTO COVERAGE PARTS PROGRAM

The Committee reviewed an AIPSO recommendation to adopt several changes to the Commercial Auto Coverage Parts Program to track more closely with ISO's commercial lines manual. The Committee voted to accept changes to the program that are applicable in WI.

The Committee also discussed eliminating the WI Truckers application. After discussion, the Committee voted to retain the current applications. This item is removed from the agenda.

ITEM NUMBER 776 2014 PRIVATE PASSENGER NON-FLEET AUTOMOBILE RATE REVIEW

The Committee discussed a proposed 8.6% decrease in overall rate level for private passenger accounts. While the indicated change is within a +/- 10% range which would not require

adoption, the Committee agreed that the change was close enough to adopt. The rate proposal will be filed with the OCI to be effective 1-1-15 applicable to new and renewal business.

ITEM NUMBER 777 2014 COMMERCIAL AUTOMOBILE RATE REVIEW

The Committee discussed a proposed 4.2% decrease in overall rate level for commercial accounts. The indicated change is within a +/- 10% range which would not require adoption. By majority vote, the Committee voted not to file the rate decrease.
