- 4. The next order of business was the election of the representatives to the Governing Committee. The following carriers were re-elected to serve a one-year term on the Governing Board:

American Family Mutual Insurance Company Employers Mutual Casualty Company General Casualty Company of WI Hanover Insurance Company Liberty Mutual Insurance Company Sentry Insurance, A Mutual Company State Farm Mutual Auto Insurance Company Travelers Indemnity Company

Employers Mutual Casualty Company was unanimously re-elected to serve as Chairperson of the Governing Committee for a two-year term.

By unanimous vote, National Continental Insurance Company was appointed as an additional member of the Governing Committee in accordance with Rule 1. in Appendix Page C. in the WAIP Manual.

5. Plan volume has been extremely low for several years. Therefore, the members voted to reduce the regular meetings of the Governing Committee to one per year in conjunction with the Annual Meeting.
