ITEM NUMBER 788 2016 WAIP BUDGET

The Committee reaffirmed their e-mail vote to accept the proposed 2016 WAIP budget. This item is removed from the agenda.

ITEM NUMBER 789 CAIP COUNTRYWIDE SELECTION PROCESS

AIPSO is beginning the bid process for servicing carriers for the CAIP programs. American Family Mutual Insurance Company volunteered to represent WI in the process.

ITEM NUMBER 790 LAD AMENDMENTS

The Committee reviewed a proposal to remove the market share threshold for LAD volume.

After discussion, the Committee requested that WAIP review all restrictions on the LAD, including participation limitations. WAIP will prepare a proposal for an email vote.

ITEM NUMBER 791 AIPSO PROPOSAL 2016 COMMERCIAL AUTOMOBILE RATE REVIEW

The Committee discussed a proposed 24.7% decrease in overall rate level for commercial accounts. Due to the continued decline in Plan volume, high loss ratio, and rate credibility

concern, the Committee voted not to file the rate change as recommended by AIPSO in the proposal.

National Continental Insurance Company abstained from voting.

This item is removed from the agenda.

ITEM NUMBER 792 AIPSO PROPOSAL 2016 PRIVATE PASSENGER NON-FLEET AUTOMOBILE RATE REVIEW

The Committee discussed a proposed 0.5% decrease in overall rate level for private passenger accounts. Due to the lack of premium volume, the Committee voted not to file the rate change as recommended by AIPSO in the proposal.

ITEM NUMBER 793 AIPSO PROPOSAL DETERMINATION OF QUOTAS – SECTIONS 44 AND 48

The Committee reviewed and adopted AIPSO's proposed changes to the quota determination methodology to be filed with the Office of the Commissioner of Insurance for approval.
