- The Committee discussed amending the Plan language of the Committee makeup and changing the requirements to a floor of no less than 4 members equally divided between stock and non-stock insurers. The amended language will be put to a vote at the Annual Meeting.
- 3. Jaclyn de Medicci updated the Committee on the Plan volume and activity report.
- 4. Item Number 820 AIPSO Proposal Symbol Factors. This item was filed with the Office of the Commissioner of Insurance and approved. This item is removed from the agenda.
- Item Number 821 AIPSO Primary and Noncontributory Factors. This item was filed with the Office of the Commissioner of Insurance and approved. This item is removed from the agenda.
- 6. Item Number 823 PAIP Proposal. Discussion continued from the previous meeting regarding the PAIP with the inclusion of exact data elements and assessment figures pending from the previous meeting. The Committee voted to approve. This item will be filed with the Office of the Commissioner of Insurance.
- 7. Item Number 825 AIPSO Private Passenger Auto Rate Proposal. The recommendation of no change to the filed Private Passenger Plan Auto Rates was approved by the Committee.
- 8. Item Number 826 AIPSO Commercial Auto Rate Proposal. The Committee voted to accept the recommended increase of 6.7% to the Commercial Auto Plan Rates. This item will be filed with the Office of the Commissioner of Insurance.

- 14. Item Number 832 PAIP Nonrenewal Plan Language. The Committee voted to approve nonrenewal language in notice forms sent to Private Passenger policyholders.
- 15. Item Number 833 WAIP Audit. The audit of the Wisconsin Automobile Plan was presented to the Committee. The Committee voted to approve the findings of the audit. This item will be filed with the Office of the Commissioner of Insurance for informational purposes.
